Minutes from Aug. 11, 2020 Meeting

A meeting of the Trailsweepers Snow and Sports Club Board of Directors was called to order by Dale Ziegenfelder on August 11, 2020 at Freer Park Port Ewen. Present: Jeff Huth, Kathie Quick, Steve Wingard, Mike Griffin. A brief follow-up meeting was held on August 25, 2020 at Freer Park Port Ewen. Present: Jeff Huth, Mike Griffin, Skip Alford.

A Covid Virus signoff form was presented by Jeff Huth. A directive to the CDC website was deleted. The form was approved and is attached. The form is to be read to members participating in TSSC activities by the leader of the activity until the board declares it is not necessary.

The board approved revisions to the waiver presented by Jeff, subject to a review of a proposed wording consolidation. The final version is attached. The updated non-member sign-in including the new waiver is attached. The board voted not to have the entire membership sign new waivers, just those attending a meeting.

The sanction of the bike/run/walk for cancer care was approved.

Dale proposed a one season only \$10 reduction of dues to compensate for the \$900 not spent on the Spring Banquet, and \sim \$500 saved in changing insurance carriers, by amending the bylaws. Also included in the bylaw change is mention of the waiver in the membership section. The change motion below will be voted on at the October 13 meeting, as proscribed in the bylaws.

Motion to amend the bylaws to read: (changes are in red)

ARTICLE V SECTION 1 - CLUB DUES:

The club dues shall be as follows:

Individual.....\$ 20.00

Couple. *\$ 35.00

(* couples shall be defined as two people living at the same residence)

Dues will include all sales tax.

Section 2-BILLS:

Bills for dues shall be mailed to members on October 15. Dues for renewal shall be paid, in person or by date of postmark, no later than November 1.

On May 31, 2021 these changes above shall revert back to the wording prior to this amendment.

ARTICLE III-MEMBERSHIP

Section 1-GENERAL:

Applicants for membership shall complete an application form, sign a GENERAL RELEASE OF LIABILITY and submit both to the membership committee chairman at a regular meeting or by mail, accompanied by one year's dues. The GENERAL RELEASE OF LIABILITY will continue in effect until the member signs a new GENERAL RELEASE OF LIABILITY or until the member discontinues his/her membership.

Minutes from Aug. 25 Meeting By Lisa Olivett

Lisa opened the meeting at 6:30 PM. after members were able to eat, drink and socialize with fellow members.

With no active Secretary, Lisa also took the minutes for this meeting.

The activities Board was reviewed and can be referred to on the TSSC Website, Calendar and Newsletter.

Dale Z asked to speak and present new COVID-19 document reading presentation. This was read and reviewed by Jeff H, instead of everyone present individually reading and signing an affidavit regarding COVID-19. In the future, the leaders of the meetings/events will read aloud. All this information will be forwarded in an Email and provided in our Newsletter and on our Website.

Dale and Jeff continued with discussion on our new/updated Waivers and Event Sign-In Sheets. These will also be Emailed, etc. when complete.

Lisa informed that Rob F has been working feverishly on our "Programs" which are scheduled for the Fall and will prove to be very interesting.

Jackie O spoke about the Ride/Run/Walk for Cancer Care which is going Virtual this year. Jackie has assumed the Role of Captain again and all information has already been forwarded via Email and will be in the Newsletter.

Jeff H has signed up as leader for one of our fall hikes and there will be several more scheduled. Lisa asked for those interested in leading a hike to please contact Steve W.

HVSC asked for those who are interested in the Telluride Ski Trip scheduled for Feb. 27 thru March 6, 2021, to please confirm by Sept. 1st or the trip will be canceled if a sufficient number do not commit. You can also go to the HVSC website to view additional ski activities.

The meeting was then open to the floor for discussion and/or new topics.

Meeting was adjourned at 7PM.
