TRAILSWEEPERS SNOW AND SPORTS CLUB GENERAL RELEASE OF LIABILITY FORM

Please Read Carefully and Sign Below

I understand that the Trailsweepers Snow and Sports Club, Inc. (hereafter the "Club") is a year-round skiing, sports and social club, which sponsors a variety of activities, including skiing, ski racing, ski instruction, camping, hiking, cycling, canoeing/kayaking, softball, and other sports and social events. I am aware that many of the Club's activities and events including but not limited to those listed above, are inherently dangerous, and involve the risk of serious injury or even death. I understand that the Club is a NY Not for Profit organization and that its members, officers, directors, committee chairpersons, committee members, representatives and instructors serve only in the capacity of volunteers. I agree that by participating in any Club-related activity or event, I am responsible for my own safety and agree that I knowingly and voluntarily assume the risks involved in any such activity or event. I agree that prior to participating, I will inspect any facilities and equipment to be used, and if I believe anything is unsafe, I will immediately advise a club officer of such condition(s) and refuse to participate. I verify that I am in generally good health and physically capable of carrying out the club activity or event in which I will participate. If I should become injured during a club-related activity or event, the Club assumes no responsibility for providing medical care and I will be responsible for paying for any medical care and/or evacuation that I may incur.

In addition, and to the fullest extent allowed by law, I agree that I will not institute or join any lawsuit or other legal action against the Club, its officers, directors, committee chairpersons, committee members, instructors, agents, representatives, servants, or assigns as a result of my participation or injury at any Club-related activity or event, whether or not due to gross negligence or intentional acts of the Club; nor will I institute or join any lawsuit or other legal action against Club members as a result of my participation or injury at any Club-related activity or event, whether or not due to gross negligence or intentional acts of the member(s), nor will I voluntarily assist anyone else in the pursuit of any such lawsuit or other legal action. I also agree to release the Club, its officers, directors, committee chairpersons, committee members, instructors, agents, representatives, servants, and assigns from any and all liability, claims, actions, suits, judgment, damages, and costs that may result by reason of my participation in or injury from any Club-related activity or event, whether any claim be caused or alleged to be caused by the gross negligence or intentional acts of the Club. I further agree to release Club members from all liability, claims actions, suits, judgment, damages and costs that may result by reason of my participation in or injury from any Club-related activity or event, whether any claim be caused or alleged to be caused by the gross negligence or intentional acts of the member(s). This Release shall bind me, my distributes, heirs, executors, representatives, successors, and assigns.

I understand and acknowledge that the Club is acting in reliance upon agreements made by me in this Release in order to extend to me the benefits of membership in the Club and/or guest participation in club activities or events and that, were I not willing to abide by the terms of this document, such membership and opportunity to participate in Club-related activities and events would not be extended to me. I further understand and acknowledge that Club members are acting in reliance upon agreements made by me in this Release in volunteering their services and, in some instances, access to their homes and that, were I not willing to abide by the terms of this document, their services and access to their homes would not be extended to me.

Code of Conduct

I understand camaraderie among the members is a crucial component of the Club's purpose and enhances the enjoyment of club activities and events by everyone. My conduct as a club member/guest impacts the public's view of the Club and the willingness of organizations to co-sponsor activities and events with the Club.
